- 1. I will not export or reexport the property, software, and/or technology to North Korea, Iran, Cuba, Syria, Sudan, the Crimea region of the Ukraine, or any other country or territory subject to U.S. trade sanctions;
- 2. I will not take any commodities, software, and/or technology incorporating Vanderbilt University Medical Center-generated, non-commercial encryption code outside the borders of the United States;
- 3. If the property is an electronic device such as a laptop, cell phone, PDA, tablet, etc., I will ensure VUMC IT has removed Vanderbilt protocols from the device prior to exporting, including protections against **unauthorized access or release** of VUMC infrastructure by:
 - a) Using secure network connectivity means (such as Virtual Private Network (VPN)) when accessing VUMC's IT infrastructure and data for business activities, that involve the transmission and access of VUMC data and information.
 - b) Using user access level controls (such as: usernames/passwords) on electronic devices and equipment that connect and store VUMC data and information.
 - c) Using network access controls (such as personal firewalls) on electronic devices and equipment to limit access to VUMC infrastructure, data, and information.
- 4. I understand this Relinquishment form is valid **only** for the property(ies) described herein, and not for any other property, equipment, software, technology, or materials:
 - a) I will ensure that VUMC IT has deleted any third party proprietary data, VUMC proprietary data, or unpublished technical data from the propert(ies) described herein.
- 5. Personal ownership and rights to the aforementioned property does not remove any other requirements, conditions, or restrictions as outlined in a separate contract, non-disclosure agreement, assurance letter, or technology control plan.

<u>Note</u>:

All exports of VUMC-owned property (even temporarily) are subject to review by VUMC Export Compliance and **may require** a license from the United States government due to certain controls. Currently, the licensing process can take several weeks. VUMC-owned export-controlled items and/or information **may not** be exported without appropriate review and/or licensing.
