TEACHING EXPERIENCE

MHS-180-01/ 1940 (Racial and Ethnic Health Disparities), Vanderbilt University Center for Medicine, Health, and Society (Fall 2013-present). (MHS 290-15: Race, Ethnicity and Health, Spring 2013). This undergraduate course trains students to systematically explore patterns, causes and interventions to reduce or eliminate racial and ethnic disparities in health using a combination of historical and current examples and resources. The course helps students to consider the role that time, fundamental, biopsychosocial and other factors play in creating and perpetuating health disparities and how their understanding of the problem, intervention goals and intervention focus must align to pursue or achieve health equity.
