The purpose of this study is to analyze recent trends in nursing home ownership (e.g., for- profit/not forprofit, chain affiliation, private equity ownership, real estate investment trust) over the past 10 years and whether ownership type affects quality of care to residents. Findings from this study will inform nursing home policy to ensure high quality of care. Completion of this research will address i) how nursing home ownership structure has changed over the last 10 years; ii) how these changes have affected the nursing home market (e.g., market share of the various types of ownership and competition); and iii) the implicitons of these changes for nursing home quality of care and disparities.
