EDUARDO C. ALFONSO, M.D.

EDUARDO C. ALFONSO, M.D., Director of the Bascom Palmer Eye Institute and the Kathleen and Stanley J. Glaser Chair in Ophthalmology is the chairman of the department of ophthalmology, University of Miami Miller School of Medicine.

Physician surgeon, professor, researcher and administrator, Alfonso is a cornea specialist with a special interest in corneal transplants. The medical director of Bascom Palmer's Ocular Microbiology Laboratory, he is an internationally known expert on ocular infectious diseases.

Alfonso completed his undergraduate degree at Yale College, summa cum laude, and his medical degree from the Yale University School of Medicine. He joined Bascom Palmer and the University of Miami

School of Medicine in 1981 as a resident.

He then completed fellowships in corneal and external diseases, ophthalmic pathology, and research at the Massachusetts Eye & Ear Infirmary of Harvard Medical School. Dr. Alfonso joined the faculty of Bascom Palmer in 1986. He was appointed director of Bascom Palmer in 2007 and chairman in 2009. During his tenure as director, Bascom Palmer Eye Institute has been ranked as #1 in Ophthalmology each year by U.S. News& World Report. He has served in leadership roles at the University of Miami.

A renowned medical academic leader, Alfonso is past president of several organizations including the Association of University of Professors of Ophthalmology, the Pan-American Association of Ophthalmology and has served on the board of others. He has been inducted into the American Ophthalmological Society, the Academia Ophthalmologica Internationale, and the Cornea Society. He has been honored with over 20 invited lectures and has received numerous awards.

Dr. Alfonso and his wife live in Key Biscayne, Florida; enjoy the outdoors and their children and grandchildren.

The William S. and Grace Snyder Lectureship in Ophthalmology was endowed by William B. Snyder, M.D., and his wife, Phyllis, in memory of Dr. Snyder's parents, both of whom practiced medicine in the state of Kentucky.

Dr. and Mrs. Snyder have been longstanding supporters of the Vanderbilt Eye Institute and Vanderbilt University Medical Center. Dr. Snyder is a 1957 graduate of the Vanderbilt University Medical School and a senior partner in Texas Retina Associates based in Dallas, Texas. Dr. and Mrs. Snyder established the William S. and Grace Snyder Visiting Professorship in Ophthalmology and provided a lead gift to establish the J. Donald Gass, M.D. Endowed Fellowship. Dr. Snyder has provided additional leadership following his appointment as Chairman of the Vanderbilt Eye Institute Advisory Board in 2005. In 2006, Dr. and Mrs. Snyder established the Phyllis G. and William B. Snyder Chair in Ophthalmology and Visual Sciences.
