

State of TN & Vanderbilt University Required Immunization Detail

***M.M.R. (MEASLES, MUMPS, RUBELLA)- 2 doses required for all students -or- positive titer :**

*Vaccine Detail- Dose #1 given at age 12 months or later, Dose #2 given at least 28 days after first dose
-If vaccination records are not available, we will accept official titer report showing positive IgG immunity for measles, mumps and rubella. Titer must be administered after age 16.*

-You are exempt from the M.M.R. requirement if born prior to 1956.

All Students required to submit MMR documentation to Student Health Center Portal.

Nursing Students will also need to submit to the School of VUSN Nursing Portal (EXXAT).

***VARICELLA - 2 doses required for all students -or- positive titer -or- documented HX (see detail):**

-Vaccine Detail- Dose #1 given at age 12 months or later and after the year 1995, Dose #2 given at least 28 days after first dose & after the year 1995

-If vaccination records are not available, or you had the chicken pox disease, we will accept official titer results showing positive IgG immunity. Titer must be after age 16.

*-We will accept History of the Disease (Chicken Pox) for **domestic/non-international UGRD and GRAD students ONLY**. If you had the disease, documentation must be on a medical record, or provide a written statement from a parent or provider including student full name, the month and year of the disease, and contact information for parent.*

-You are exempt from the varicella vaccine and requirements if UGRD/GRAD born prior to 1980.

All Students required to submit Varicella documentation to Student Health Center Portal.

Nursing Students will also need to submit to the School of Nursing Portal (EXXAT).

***MENINGOCOCCAL- ACWY (for bacterial meningitis)- 1 dose after age 16:**

*Vaccine must be administered **after age 16** - You are exempt from this requirement if you are **NOT** living on campus
If you had one or two doses before age 16, these are not valid for college entry. Dose must be after age 16.*

Meningococcal B is not valid for State of TN requirement, although it is a recommended vaccine.

UGRD Students living on campus required to submit documentation

***TB Screening Survey-** <https://redcap.vumc.org/surveys/?s=TFLTRT4THC>. Take the survey, submit to the database, save the .pdf to your files for later upload to the Student Health Portal.

- TB Blood testing is only needed if the risk factors indicate and testing form will then be provided.

- All VUSN /VUSM students will be required to have blood testing done within 3 months of program start. Read carefully. TB Skin testing not accepted. **All Students required to submit TB survey (and testing report if applicable).**

***Clinical Programs for VUSM and VUSN Students have additional requirements required by State of TN, VUMC or SHC & will need to upload:**

-3 Hepatitis B vaccinations or 2 *Hepilisav* B (VUSM and VUSN Clinical Programs) or Reactive Titer

-Additional Hepatitis B reactive titer (VUSM MD/MSTP programs only) with documentation of vaccines

-TDAP vaccination – adult dose after age 19 and within the past 10 years (VUSM Clinical and VUSN Programs)

Optional Reporting Vaccinations (For continuity of care at Student Health)-registration not held.

COVID-19, Hepatitis A, Hepatitis B, HPV, Influenza, Meningococcal B, Polio, Tdap, other travel vaccines.

Student Health will document official records of additional vaccines as part of your VUMC Medical Record. We will not share these immunization details with VU per HIPAA guidelines.
