#### Target Audience

Physicians, advanced practice nurses, clinical researchers, and other healthcare professionals involved in the diagnosis and management of TB disease and M. *tuberculosis* infection.

#### Course Overview

Geared toward clinicians, this event will engage participants through lecture and discussion of Tennessee's TB cases, with an analysis of clinical challenges and opportunities by a panel of clinical and laboratory experts. Local lodging is available.

- Treatment of Latent TB Infection

- Challenges in the Management of Pan-sensitive TB

#### Upon completion of this course, the participant will:

- Increase awareness of why MDR-TB threatens global health and implications of its effects locally to improve the case rates of TB in local areas.
- Identify the risk-factors for MDR-TB to ensure appropriate evaluation and initial treatment Gain expert insight for the medical management of TB, including MDR-TB, pediatric TB, HIV/TB co-infection and other co-morbidities.
- Identify the epidemiology of diabetes in the TB population to increase the awareness of treatment complexities for providers who treat this challenging population.
